But certain populations are falling behind and need new targeted strategies including gay and bi migrant, refugee, Aboriginal and Torres Strait Islander and incarcerated populations.

If I am re-elected I will call for additional funding for these priority groups.

When these laws were introduced I worked to encourage the government to instead introduce laws that encourage mutual responsibility between parties to prevent the transmission of sexually transmissible diseases. At the time, the government did not agree with my proposal and if I am re-elected, I will raise this matter with the new health minister and determine the most effective pathway for reform.

There is a need for continuous research into LGBTIQ+ communities, particularly around priority populations. LGBTIQ+ people still have poor health, mental health and wellbeing and this can be heightened in other communities. More research will help identify better supports and preventative measures.

In addition to a dedicated minister, there needs to be a dedicated department unit taking responsibility and coordinating with departments, agencies and ministers and ensuring the delivery of holistic programs.

Comment

We will only improve outcomes for LGBTQIA+ people if we listen to them to better understand their challenges and establish solutions together. An advisory council covering various organisations should be created to consult with LGBTQIA+ communities to promote equality.

- narrow exceptions allowing discrimination against trans and gender diverse people in sport?
- remove exceptions allowing discrimination against trans and gender diverse people in superannuation?

Comment

The Anti-Discrimination Act 1977 is no longer fit for purpose and needs a rewrite to modernise its approach to discrimination. If re-elected, I will call for a rewrite while also introducing a private members bill to expand protections for all LGBTIQA+ people, provide protections against discrimination for sex workers, remove exceptions for private educational authorities and religious organisations, narrow exceptions for trans and gender diverse people in sport and repeal exemptions on superannuation providers that allow them to discriminate against trans and gender diverse people.

Comment

Requiring trans and gender diverse people to undergo surgery to update their state documentation is archaic and fails to reflect the reality of the majority of people who are transgender. I have raised the matter with multiple ministers and the Premier, initiated discussion in Parliament and drafted legislation. My Equality Bill will include reforms to ensure all trans and gender diverse people can update their gender markers on birth certificates.

- 21.** Introduce legislation preventing so-called 'normalising' medical interventions on people with innate variations of sex characteristics without their personal consent?

Comment

If re-elected, my Equality Bill will include a framework to prohibit unnecessary medical interventions on people who have variations in sex characteristics without their consent. The reforms will likely be based on the ACT bill which is yet to be available so may not be included in the first draft of the bill.

- 22.** Commit to a review and comprehensive reforms to parentage laws to ensure families created through surrogacy or with co-parenting arrangements are properly recognised?

Children should have the protections of having all their parents recognised in law regardless of the circumstances of their birth.

My Equality Bill will include provisions for legal parentage of children born out of surrogacy, but a review is the best way forward to address all issues around parental recognition. If re-elected, I will support a review.

If elected, will you:

24. Support and actively monitor implementation of the LGBTIQ+ Health Strategy for the entire term of government, including evaluation reporting, and embedding the goals of the Strategy across all other health Strategies? These goals include:

- Deliver high-quality, safe, inclusive and responsive healthcare, including:
 - Education and training
 - Mental health and suicide prevention
 - System responsiveness

I advocated for the LGBTIQ+ Health Strategy and strongly believe that we need to continually measure and monitor progress in achieving the goals and targets set. If re-elected, I will hold the government to account for action and outcomes throughout the next term and the period of the strategy.

25. Implement reforms to ensure transgender young people are allowed to legally consent to gender-affirming medical treatment with the consent of one parent or on their own when they have the maturity to do so?

Transgender children and young people face barriers to gender affirming treatment that other young people do not have to deal with in accessing treatment. I am currently consulting with trans and gender diverse stakeholders on how to best ensure competent young people can access gender affirming care for inclusion in my Equality Bill.

26. Ensure that NSW continues its world-leading commitment to innovative, evidence-based responses to infectious diseases that are grounded in partnership with affected communities and researchers, in light of the evolving MPXV and COVID-19 climates?

Comment

My advocacy helped secure urgent access to monkey pox vaccines for at-risk populations and then for the broader population ahead of WorldPride. The quick response has helped prevent stigma while protecting the community. If re-elected, I will continue to support evidence-based responses to infectious diseases.

Comment

I acknowledge concerns raised by First Nations LGBTQ+SB stakeholders that the NSW LGBTQ+SB Health Strategy lacked culturally sensitive information and approaches. I share concern that First Nations LGBTQ+SB people have poorer outcomes and may not access mainstream services. If re-elected I would support a Aboriginal and Torres Strait Islander specific health strategy, and I intend for my Equality Bill to include provisions for First Nations LGBTQ+SB data collection.

28. Ensure that there is always a focus on, and consultation with, Aboriginal and Torres Strait Islander LGBTQ+SB peoples when developing government strategies, and evidence-based frameworks for health provision?

Comment

If we are to close the gap, we must consult with First Nations people and organisations on every aspect of health and welfare policy. I am committed to working with Aboriginal and Torres Strait Islander led organisations on LGBTQ+SB policies and more broadly support the Uluru Statement of the Heart, an Indigenous voice to Parliament and treaty.

29. Provide support and services that recognise the unique needs of older people in our communities, including social isolation programs and social housing initiatives?

Comment

If re-elected I will call for targeted programs for older LGBTQIA+ people living in supported accommodation who may not be accessing the services they need due to past experiences of discrimination, stigma and even violence.

I have called for a reduction in the age for priority housing to 55 years to prevent older people ending up in crisis. I will continue this push if I am re-elected.

30. Commit to safe and inclusive crisis accommodation and social and affordable housing across NSW?

Improving housing affordability has been a priority for me since I was elected and will continue to be for as long as our system fails to ensure everyone has access to safe, affordable housing. We need to build 5,000 new social housing homes every year for the next 10 years, require at least 20 percent social and affordable homes in major redevelopments and expand innovative solutions such as shared equity and co-operatives.

The inquiry into health outcomes and access to health and hospital services in rural, regional and remote New South Wales found severe gaps in healthcare in country areas and we know that LGBTIQ+ people fare worse than their peers. While I represent the inner city, I share concerns about the health crisis in regional areas and if re-elected, I will call for service improvements to include better services for LGBTIQ+ people. I have made a number of successful funding requests on behalf of LGBTIQ+ organisations wanting to expand services in rural, regional and remote areas and will continue to do so while the need remains.

Comment

I support the recommendations of the ice inquiry and oppose criminal sanctions for personal drug use, drug dog detections operations and strip searches, and support pill testing. If re-elected I will continue to push for harm minimisation to replace the damaging criminal approach to drug use which does nothing but encourage risky behaviour and prevent people from seeking help if they need it.

33. Develop an evidence-based whole-of-government Alcohol and Other Drugs Strategy that prioritises health initiatives, commits funding to harm reduction and early intervention programs for priority populations, and is produced in co-design with people with lived experience of drug use?

Comment

I am a member of the NSW Parliament Harm Minimisation Roundtable and we continue to call for a whole-of-government drug summit to develop a new drug strategy based on evidence and harm minimisation. The summit would provide the opportunity for those with lived experience and those on the frontline to contribute to a new approach. I will continue this advocacy if re-elected, including a push for programs to be developed with the input of people with lived experience.

34. Provide funding for tailored, community-led programs for people of diverse genders and sexualities that:

- provide early interventions into alcohol and other drug use
- respond to chronic and long-term use of alcohol and other drug use; and
- seek to address the modifiable risk factors for cancer, such as alcohol and tobacco use?

If re-elected, I will continue to call for LGBTIQ+ targeted drug and alcohol programs to ensure they feel they can access them and to help reduce harm, intervene early to change behaviour and improve the health of people with chronic habits.

- invest in community-led service delivery, research, policy and legal change, and improvements in data collection

Comment

Despite high rates of sexual, domestic and family violence experienced by LGBTIQ+ people, policy has focused on cisgenderism and heteronormativity at the expense of addressing the unique challenges LGBTIQ+ victims and survivors face. I have always consulted with LGBTIQ+ organisations on sexual, domestic and family violence matters to bring their voice to decision-makers and my amendments to the coercive control laws will see specialist committees established to provide advice on implementation. If re-elected, I will continue to support the inclusion of the LGBTIQ+ community in developing safe responses to sexual, domestic and family violence.

36. Commit to a whole-of-government approach to developing and implementing intersectional and inclusive sexual, domestic and family violence policy in NSW, in line with the Seven Calls to Action to End Gendered Violence?

My Equality Bill will include this needed reform. Part 3 is a hangover from criminalisation that serves no purpose but can create stigma and make life difficult for sex workers and their families.

39. Commit to a transparent process and timely government response to the Special Commission of Inquiry into LGBTIQ hate crimes that reflects the importance of this historical redress?

Comment

I have a long history of engaging with NSW Police to make policing safe for LGBTIQ+ communities, from addressing violence at the 2014 Mardi Gras to getting NSW Police to review past cases of potential gay hate crimes.

It is my hope that the Special Commission of Inquiry will bring to light past wrongs where LGBTIQ+ safety and justice were disregarded, and violence condoned or encouraged, while providing scope for justice. LGBTIQ+ policing will need reforms to heal the past and ensure these wrongs don't happen again.

If I am re-elected, I commit to working with the government and NSW Police to establish an appropriate response to restore relations with LGBTIQ+ communities and ensure they have access to safe policing. The Special Commission of Inquiry has shown how important it is to have independent
